Transferable, Limited Lifetime Warranty

Product Warranty

LeavesOut, Inc. warrants to the initial purchaser of LeavesOut that the LeavesOut finish will not chip, peel, flake, or blister under conditions of ordinary wear, if installed according to our specifications, for as long as you own the property. This Limited Lifetime Warranty may be transferred with the property as specified under "warranty transfer". LeavesOut is manufactured from a high-tech Alcoa® aluminum with two full coats of waterborne acrylic emulsion on both sides. This exceptional finish out-performs other coatings, even specially formulated polyesters, in color-hold, adhesion and corrosion resistance. This product warranty is limited to the cost of the material and does not include the cost of labor to install replacement material.

Performance Warranty

LeavesOut, Inc. warrants that, when LeavesOut has been installed in accordance with established installation instructions, the product will keep gutters free flowing. Gutters must be thoroughly cleaned out, properly sloped, and downspouts and drains cleared of any debris or obstructions including the removal of downspout screens. 2"x 3" downspouts must either be replaced by 3"x 4" downspouts or a product such as Big Mouth™ installed on the 2"x 3" downspout. If within 90 days of installation by a certified installer you are not satisfied with the product performance, and the installer has not been able to correct the problem, then company policy provides for the product to be removed and your money refunded. For this warranty to be valid, LeavesOut must have been installed by a certified installer of the product.

Other Limitations

1. The warranty is void if LeavesOut has been modified or tampered with. LeavesOut does not warrant and will not be responsible for any costs, defects or damages related to removal or reinstallation of the product or its components. When the roof material is to be replaced the LeavesOut installer should be contacted to coordinate removal and reinstallation of LeavesOut in order for the warranty to remain valid.
2. We do not warrant painting over the original special finish or damage caused by ladders being placed against the gutter. Damage due to natural causes, e.g. wind, hail, or violent storms is not covered.
3. The warranty does not cover changes in surface color resulting from chalking, fading, soiling or staining over time including airborne stains, mold and mildew accumulation. Such staining can be removed by occasionally washing with clear water as described in paragraph 7.
4. We reserve the right to inspect any damage before settling claim by replacement.
5. The use of unapproved parts or products of another manufacturer nullifies this warranty.
6. Other items not covered by the warranty include leaking gutter end caps, downspouts and miters; accumulation of debris on roofs and in valleys behind the deflectors; accumulation of debris on top of LeavesOut which bridges the gap between the cover and the gutter; and ground drains which have been damaged or plugged with plant roots.

7. The LeavesOut gutter cover system is designed to be virtually maintenance free. Under particularly heavy tree cover, some debris may build up on the nose of the product causing temporary bridging of water. The debris can be removed from the ground either by using a telescoping rod with a soft-bristle brush attached or a garden hose with a high-pressure nozzle attached (available from most hardware stores). On lower-pitched roofs some debris may collect behind the valley deflectors. Normally, wind and rain will remove most, if not all, of this debris. However, it may be necessary to occasionally sweep the debris from behind the valley deflectors by standing below on the ground using an extension rod with brush attached. Under certain winter conditions, small icicles may form on the nose of LeavesOut. This is normal, and LeavesOut will continue to work by preventing the buildup of ice inside the gutter. The icicles will fall away as soon as melting begins. If you have any concerns about the performance of LeavesOut, you are encouraged to contact your installer.

8. No employee, representative, or agent of LeavesOut, Inc. nor any other person has authority to assume or incur on behalf of LeavesOut, Inc. any obligation, liability or responsibility in place of, or in addition to, this warranty.

9. This warranty gives you specific legal rights and you may have other rights that vary from state to state.

Warranty Service

Claims for failure or defects under this warranty should be sent to the certified installer for service and resolution. Service calls for non-warranty repair or adjustment may result in a service charge.

Warranty Transfer

Subsequent property owners may transfer this warranty by providing written notice to LeavesOut, Inc. within 30 days after the date of transfer of ownership. The notice should include the address of the property, the name and mailing address (if different) of the new owners and the date of transfer. Upon transfer, the warranty period will be no more than twenty (20) years from the date of the original installation of LeavesOut on the property. The notice should be sent to LeavesOut, Inc. 6285 Brevard Rd. Etowah, NC 28729. Upon transfer of the property, your obligations become the obligations of the new property owners.
